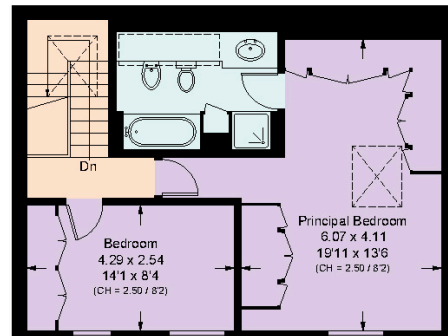




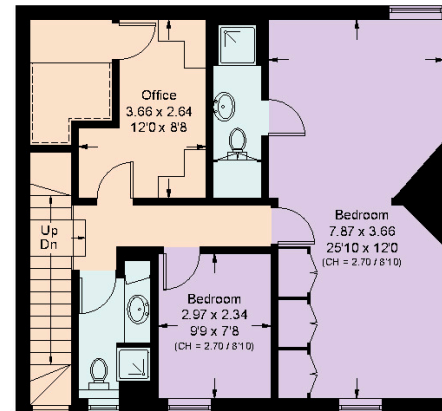

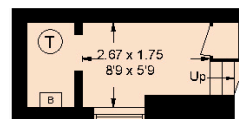


Second Floor

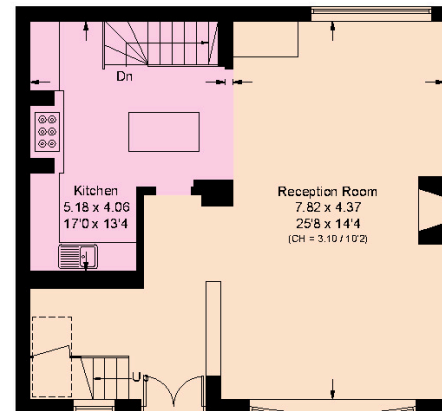


First Floor
