

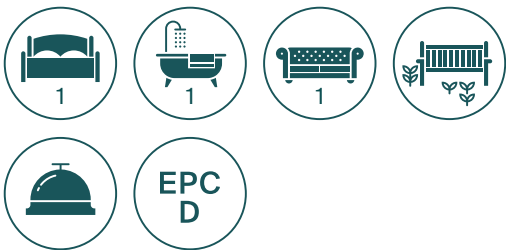
Tedworth Square, Chelsea SW3

This well-arranged property has a large and spacious reception room, with space for a dining area, excellent storage and a modern kitchen. Underground parking is available by separate negotiation.

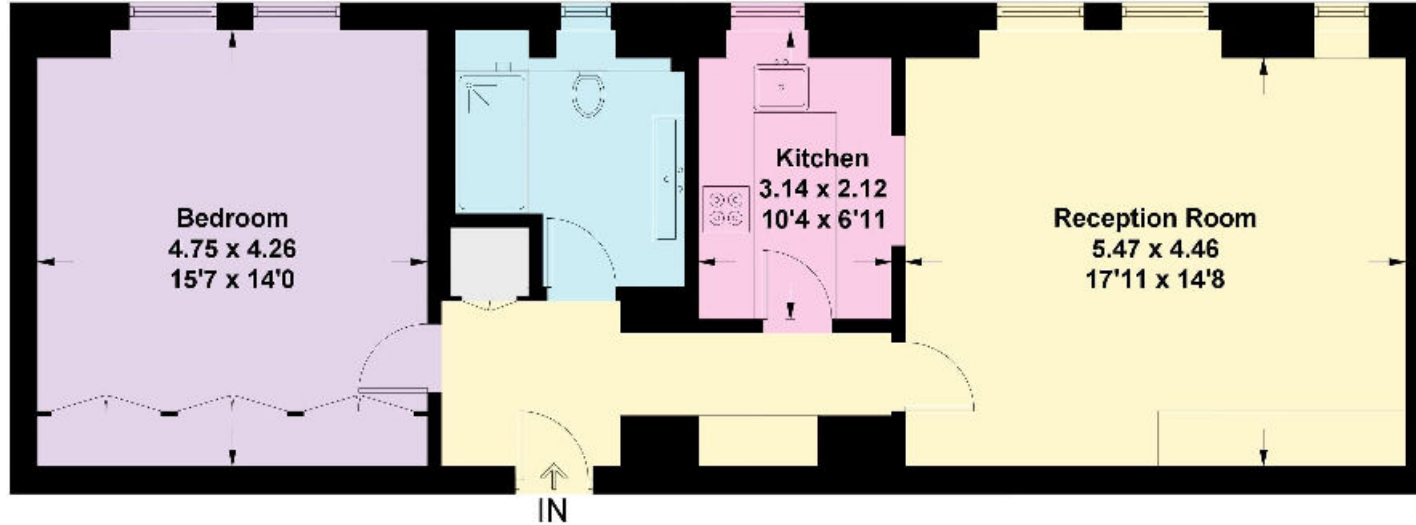
