First Floor

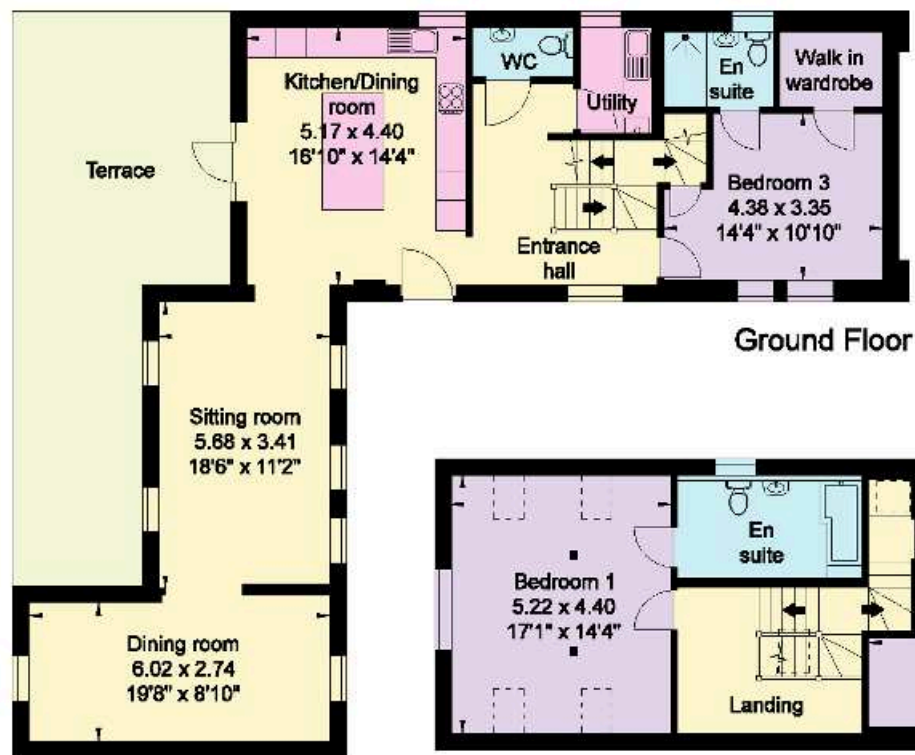
