A wonderful four bedroom family home in the heart of South Kensington.

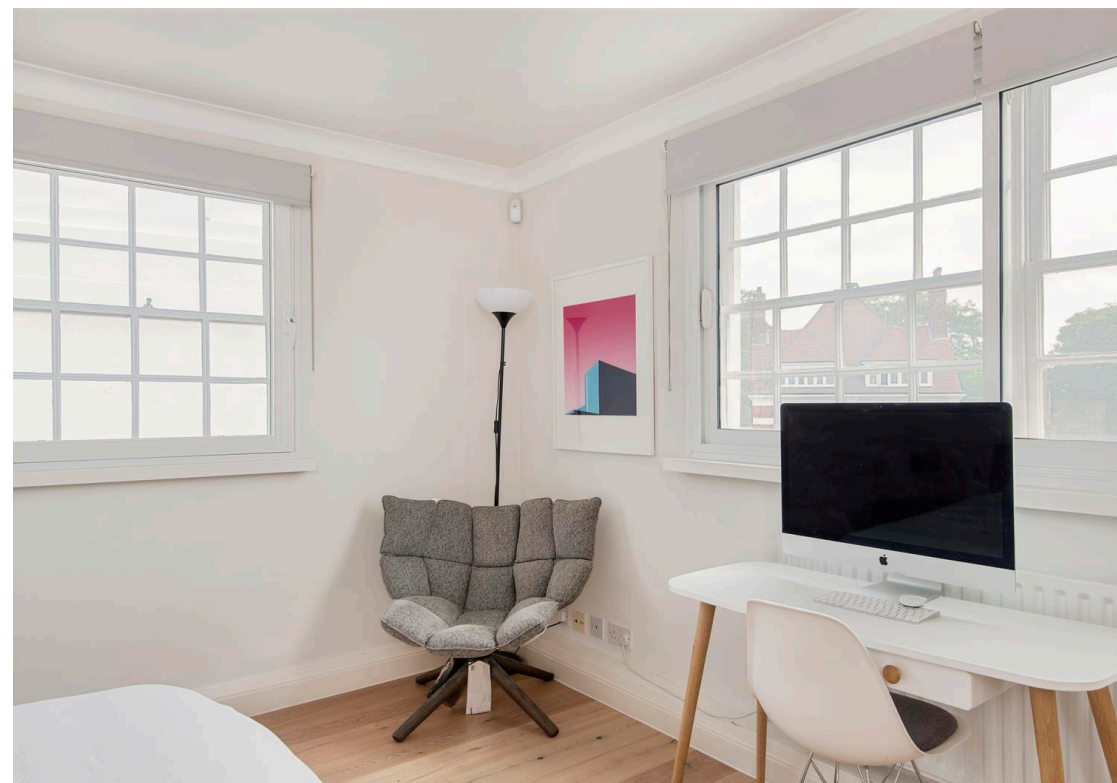
Tucked away on a quiet road, this 1512 sq. ft beautiful terraced house is set across three floors and offers a vast amount of living space.

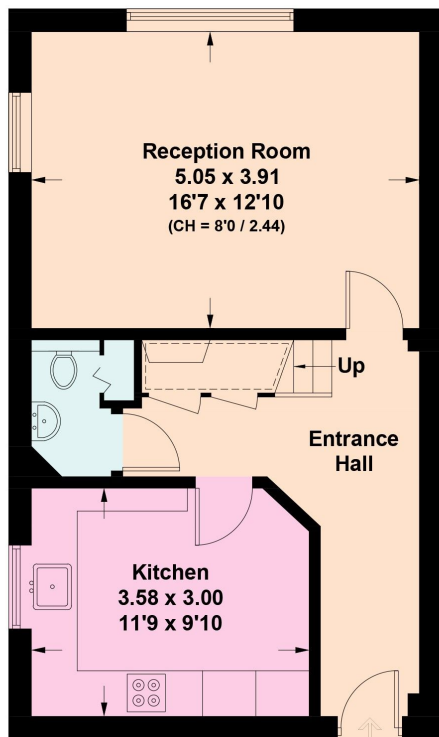

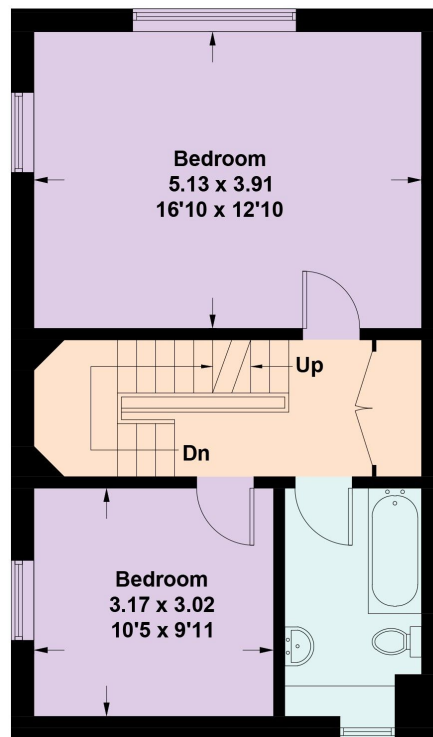

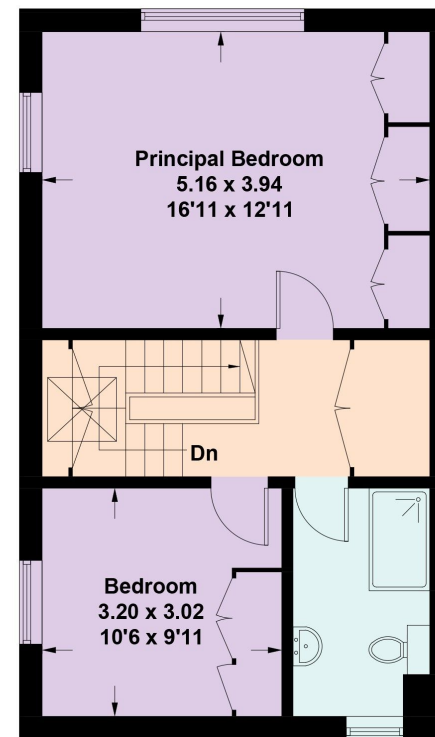
