A set of floor-to-ceiling bespoke bi-folding doors open out to a secluded, south-facing paved garden with wonderful green views. A fully fitted study is also on this floor with access to the garden.

The lower ground floor is home to an impressive open-plan reception/dining room/kitchen with high ceilings of c.3.12 meters, which have access to a private terrace. There is also a bedroom suite on this floor, along with a utility room and guest WC.

The house is well arranged over 3,294 sq ft, benefiting from wood and stone floors throughout, underfloor heating and air-conditioning in the bedrooms.

Wetherby Place is situated off Hereford Square and enjoys a unique and tranquil village-like atmosphere, and benefits from the many shops and restaurants this area has to offer. The property is within walking distance of South Kensington and Gloucester Road underground stations.
















