Location

Upper Oddington is a particularly attractive village located in an area renowned as one of outstanding natural beauty. Amenities within the village include a church, and two well-regarded public houses, The Fox Inn and The Horse and Groom. The renowned Daylesford Organic Farm Shop is just a mile and a half away, with further shopping facilities being found in the nearby market towns of Stow-on-the-Wold and Chipping Norton.

More comprehensive facilities can be found in Cheltenham, Stratford-upon-Avon, Oxford and Banbury. A number of similarly well regarded villages can be found nearby with the likes of Kingham with its two pubs and village shop, Bledington with the popular Kings Head Inn and village shop and Churchill with the Chequers Inn.

Sporting facilities in the area include racing at Cheltenham and Stratford-upon-Avon, golf courses at Lyneham, Naunton Downs and Burford, rugby at Worcester and Gloucester.

A number of public footpaths and bridleways offer the opportunity to take in the glorious countryside scenery.



Property

Rose Walk Cottages provide a terrace of four individual cottages which are currently run as a very successful holiday letting business. These beautiful Cotswold stone cottages are perfectly located in the heart of the village to access all that the North Cotswolds has to offer.

Cottages 1, 3 and 4 each provide an open plan living space on the ground floor with fitted shaker style kitchen units complete with Aga, dining space and a cosy area in front of the fireplace which benefits from a wood burning stove. Stairs lead to a landing on the first floors, each with a double bedroom and en suite. Cottages 3 and 4 also have the benefit of a recent front porch extensions.

Cottage 2 is the largest of the cottages with a generous kitchen breakfast room on the ground floor with a range of fitted units and Aga, and a well-proportioned sitting room with fireplace and wood burning stove. Two double bedrooms are on hand on the first floor, one with en suite shower room plus a family bathroom.

Proceed down the hill and take the first right hand turning into Back Lane, the driveway for the cottages will be found after approximately 150m on the left hand side.

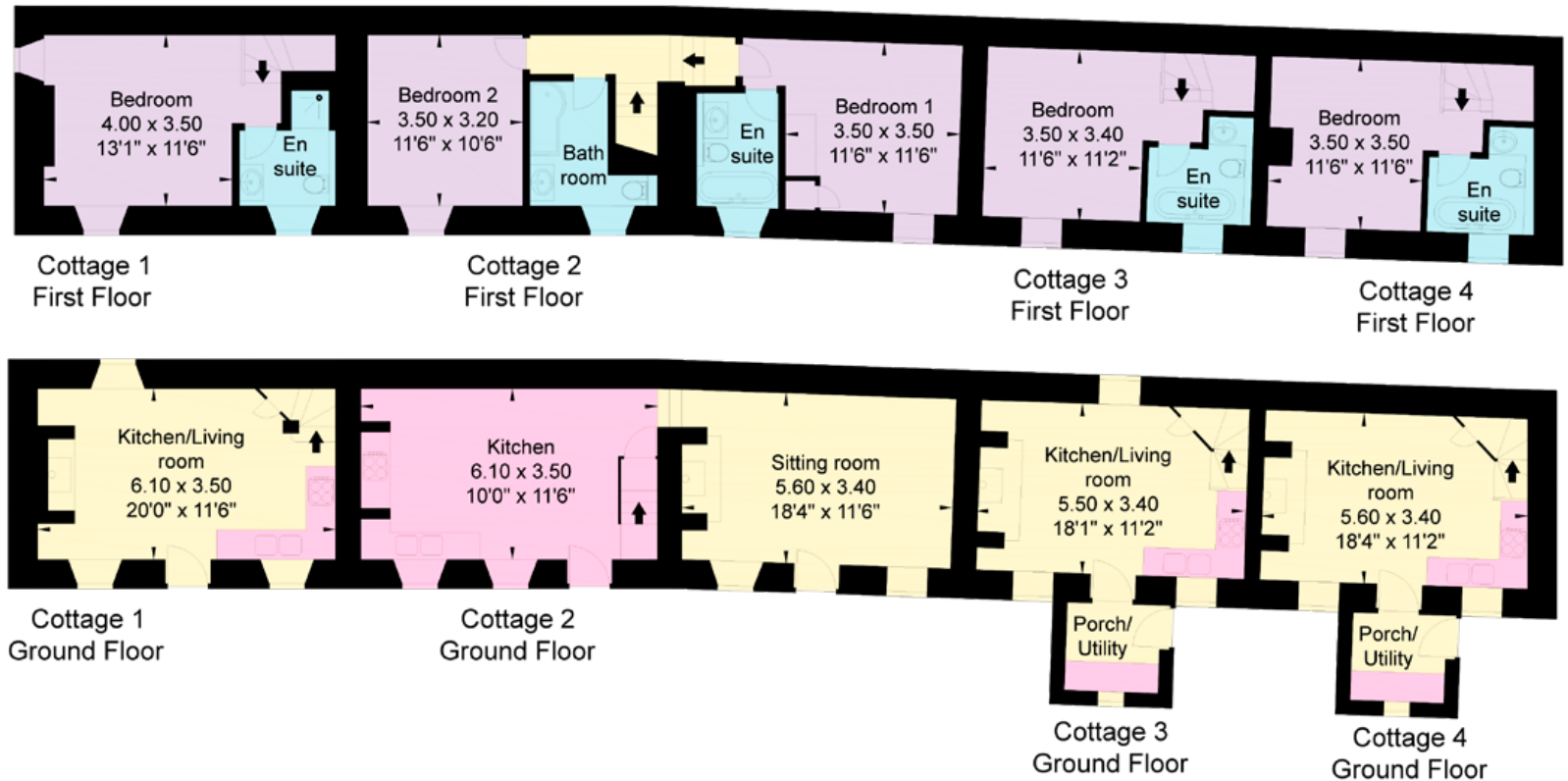
