

Chittenden Cottage Hawkhurst Kent





Chittenden Cottage, High Street, Hawkhurst, Kent, TN18 4PX.



An attractive Grade II listed detached cottage, in close proximity to the local amenities of Hawkhurst village and within the Cranbrook School catchment area. Although the property is in need of modernisation, it offers flexible family accommodation with a wealth of period features.

Hawkhurst village centre 0.5 miles. A21 (Flimwell) 2.3 miles. Cranbrook 4.2 miles. Etchingham station 4.6 miles (London Bridge from 75 minutes). Staplehurst station 10 miles (London Bridge from 52 minutes). Tenterden 11 miles. Ashford International 22.3 miles (London St Pancras from 36 minutes). Tunbridge Wells 13.5 miles. M25(J15) 26 miles. London 56 miles.

The Property

Internally, this wonderful Grade II Listed home is in need of modernisation but offers well balanced accommodation, full of period features throughout.

At the front of the house there is a covered porch leading to the front door. Upon entering you are greeted by a large reception room/dining room with stairs rising to the first floor and access into the kitchen/breakfast room at the rear of the home.

The kitchen/breakfast room is fitted with a range of base and eye level units, with a lovely outlook over the rear lawned garden and beyond. Off the kitchen there is a bathroom and a door leading to the cosy sitting room and study. The sitting room boasts an open fireplace, and is full of period charm.

On the first floor there are four great sized bedrooms, with the principal bedroom having the added bonus of a dressing room. The family shower room is off the landing.

Gardens and Grounds

The property sits centrally within its plot creating superb space surrounding the home. To the front there is a large landscaped lawned garden which could provide ample space for a large driveway and garaging subject to obtaining the necessary planning consents.

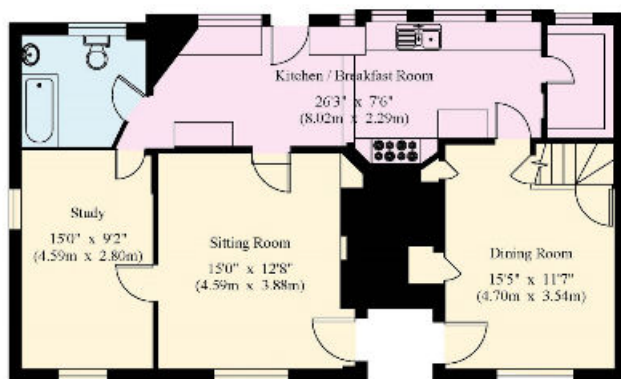

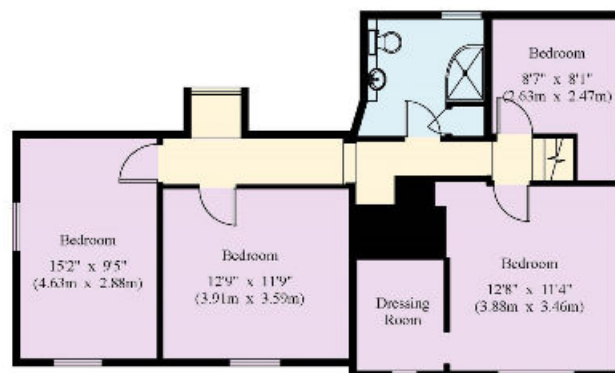

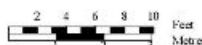

Situation

Chittenden Cottage is located on the High Street of the popular village of Hawkhurst which offers a wide range of shopping and leisure facilities including Tesco and Waitrose supermarkets, a post office, cinema and golf course. Etchingham and Staplehurst both offer mainline services to London, as does Tunbridge Wells together with an extensive range of shopping, commercial and educational facilities. The ancient town of Rye and coastal beaches are within easy travelling distance. There are a number of well-regarded schools in the area, in both the state and private sectors, including Marlborough House and St Ronan's at Hawkhurst, Dulwich Preparatory at Cranbrook, Benenden School, Holmewood House Preparatory at Langton Green, Tonbridge School. There are also grammar schools for girls and boys in Tunbridge Wells and Tonbridge and we understand the property lies within the Cranbrook School Catchment Area. Leisure facilities in the area include golf at a number of courses including Hawkhurst, Dale Hill (Ticehurst), Lamberhurst and Chart Hills (Biddenden); sailing at Bewl Water and on the south coast; walking, riding and cycling in the surrounding countryside, Bedgebury Forest and Hemsted Forest.

From Tunbridge Wells, proceed south on the A21. At Flimwell crossroads/traffic lights, turn left onto the A268 to Hawkhurst. Continue for 2.3 miles and the entrance to the property will be found on the left hand side (opposite Marlborough House School).
