Claremont Road is situated in the highly sought-after 'village' area of Tunbridge Wells, just 0.4 of a mile from the mainline station and within easy reach of shops, boutiques and restaurants on the High Street and Pantiles. The property is ideally located for the ever popular Claremont Primary School with its very small catchment area.

On the ground floor, there are two good-sized reception rooms with period features including original, fully functional fireplaces. The front reception room has a wonderful bay window and plenty of built-in storage. At the rear of the house is a modern kitchen/breakfast room with a range of wall and base units, brand new dual-fuel Rangemaster and bi-fold doors leading out into the garden. The principal bedroom is situated on the first floor with walk-through wardrobes leading to an en suite with bath, shower and 'his and hers' sinks. Also on the first floor is a further bedroom and family bathroom. On the second floor, there are three bedrooms and a useful, recently added utility room with w.c.

Outside, there is a well-maintained garden with decking and astro lawn - ideal for alfresco entertaining and family living.
