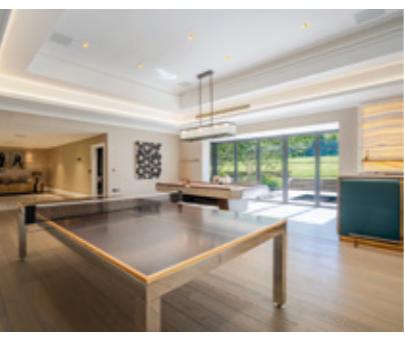
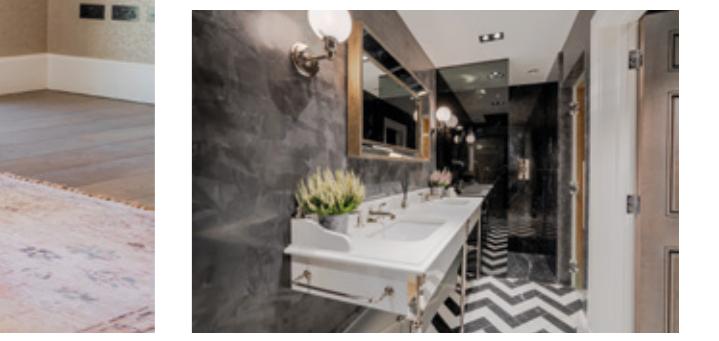
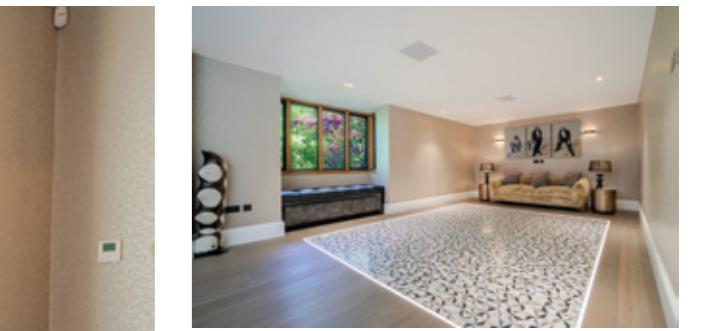
DESCRIPTION

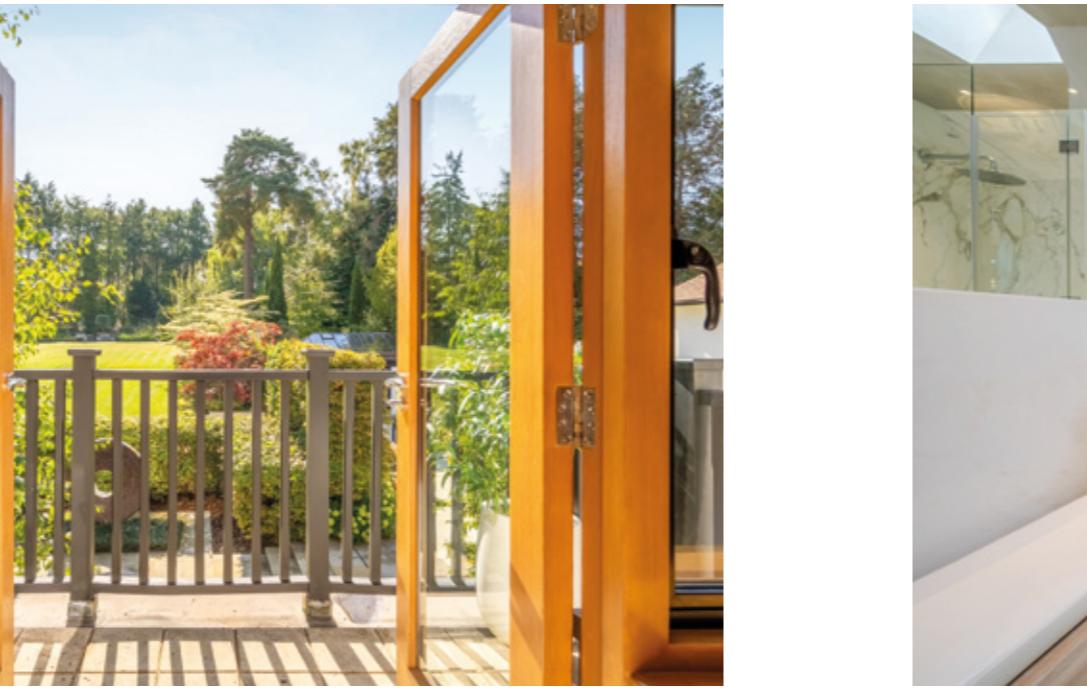
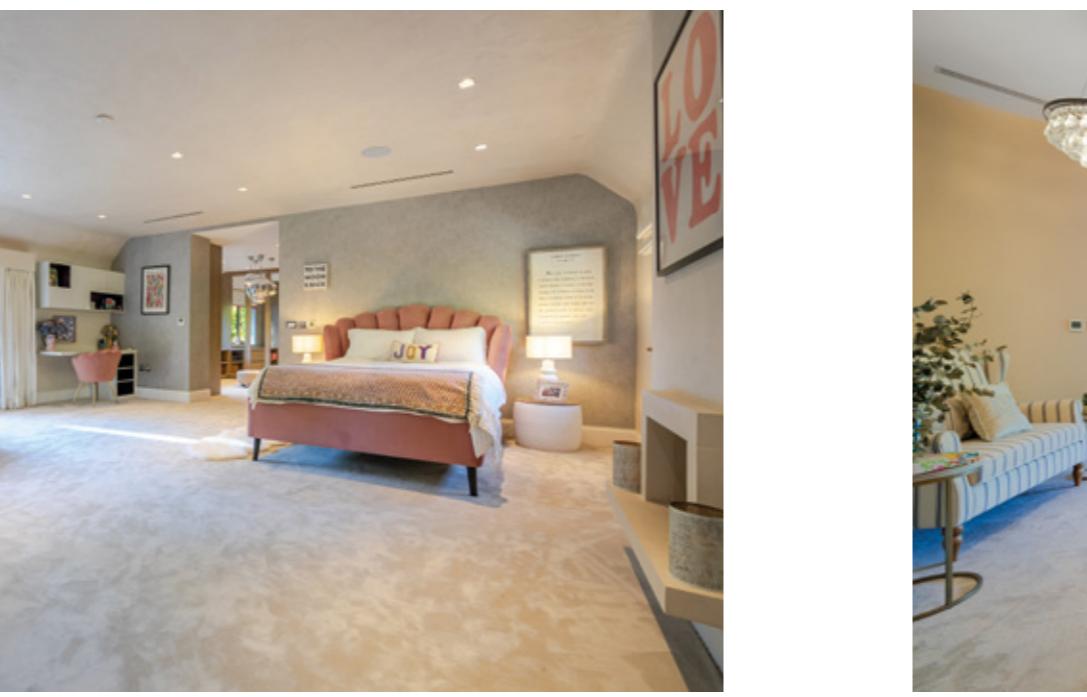
On the ground floor the majority of the reception rooms have outstanding views of the landscaped gardens and bi-folding doors opening out onto the entertaining terrace and swimming pool, which is a fantastic area for al fresco dining in the summer months. To the north and north east of the property are the sensational entertainment rooms and adjacent sauna and changing facilities.

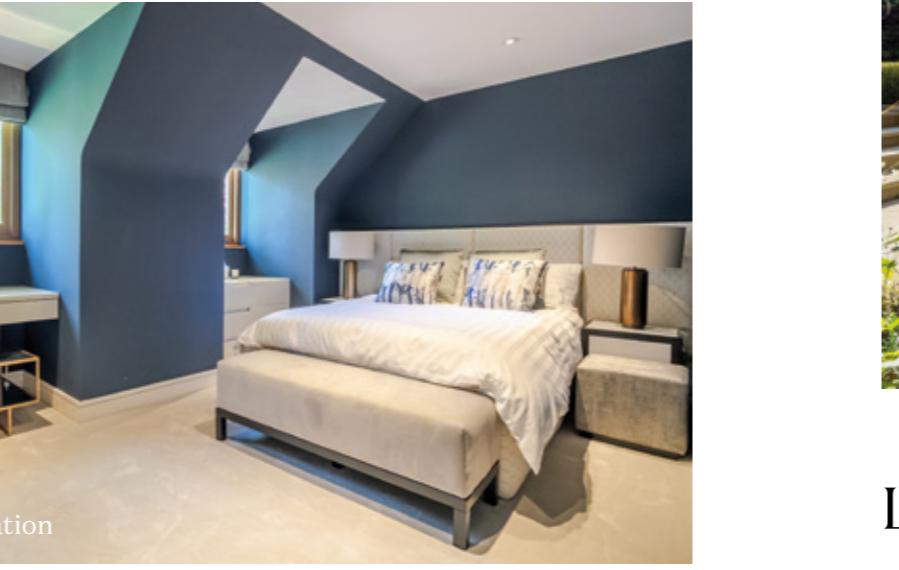




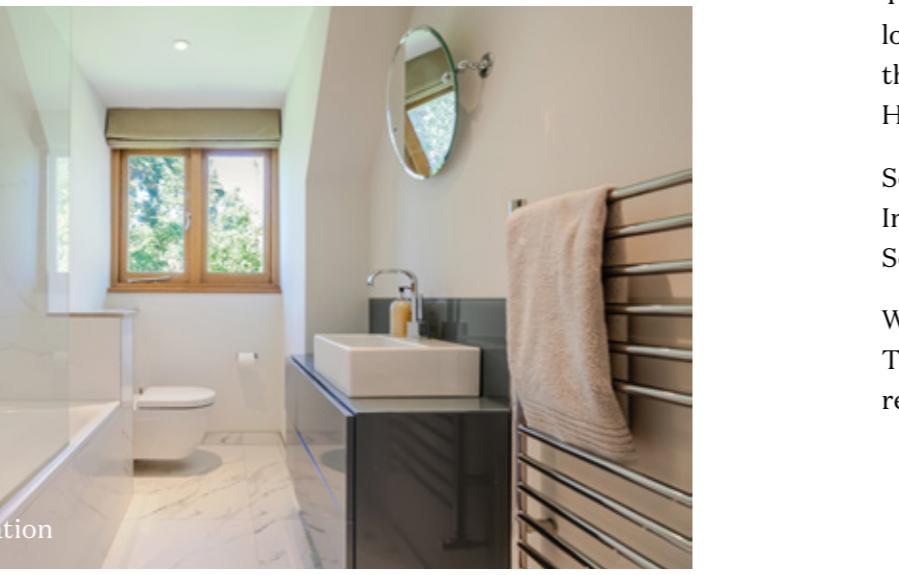

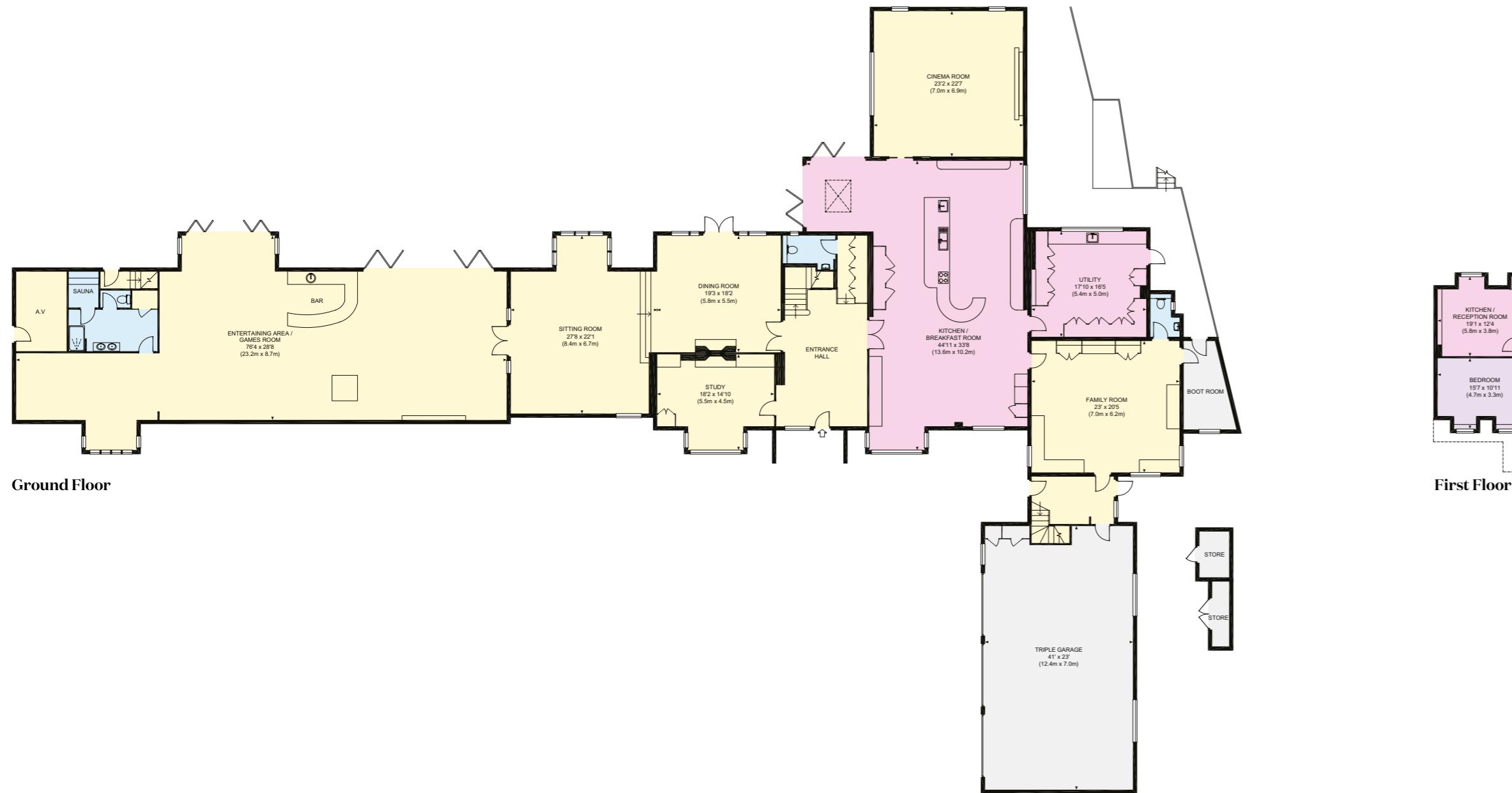
LOCATION

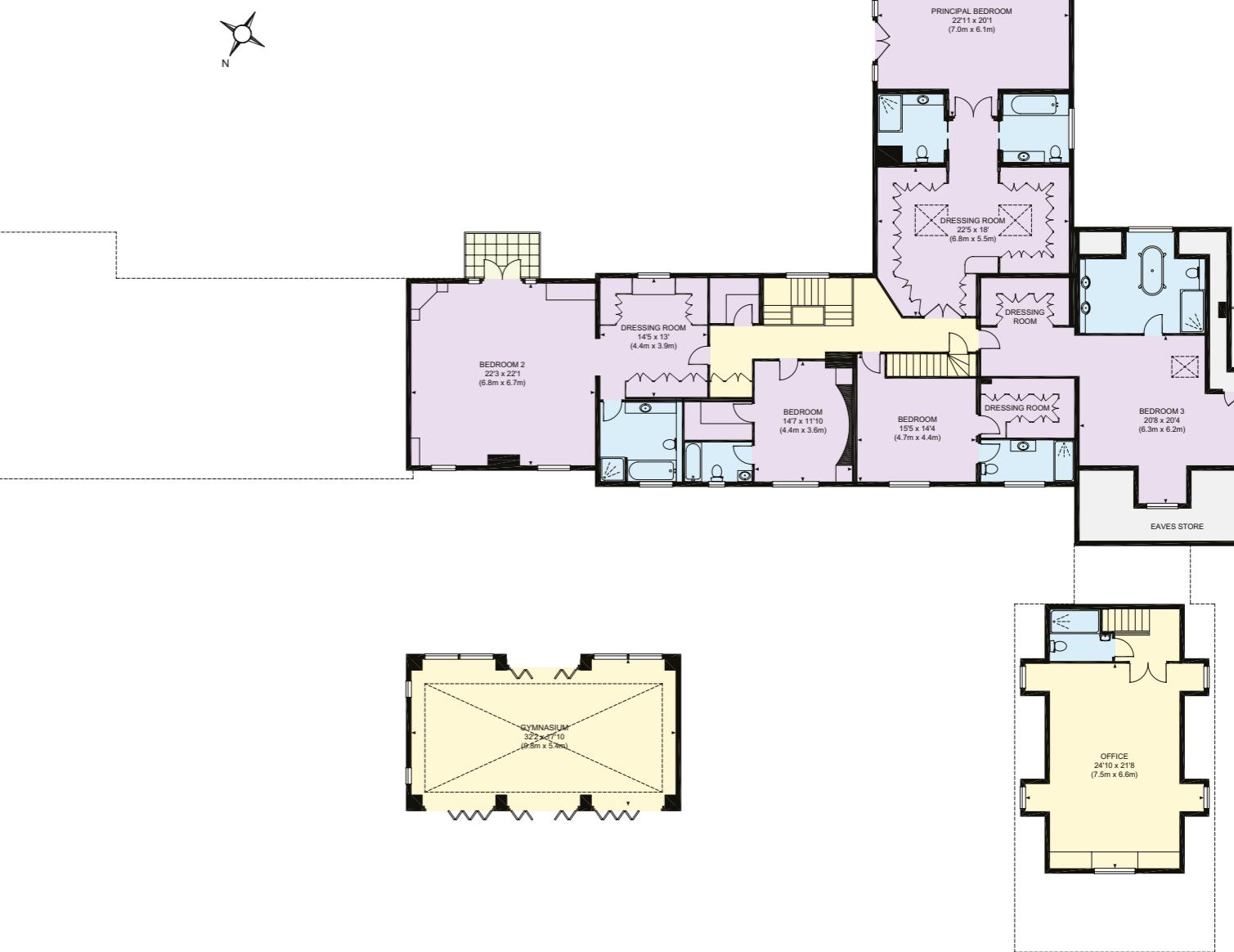
Schooling in the area is excellent and includes the ACS Cobham International School, Claremont Fan Court School in Esher and St George's School/College in Weybridge.
