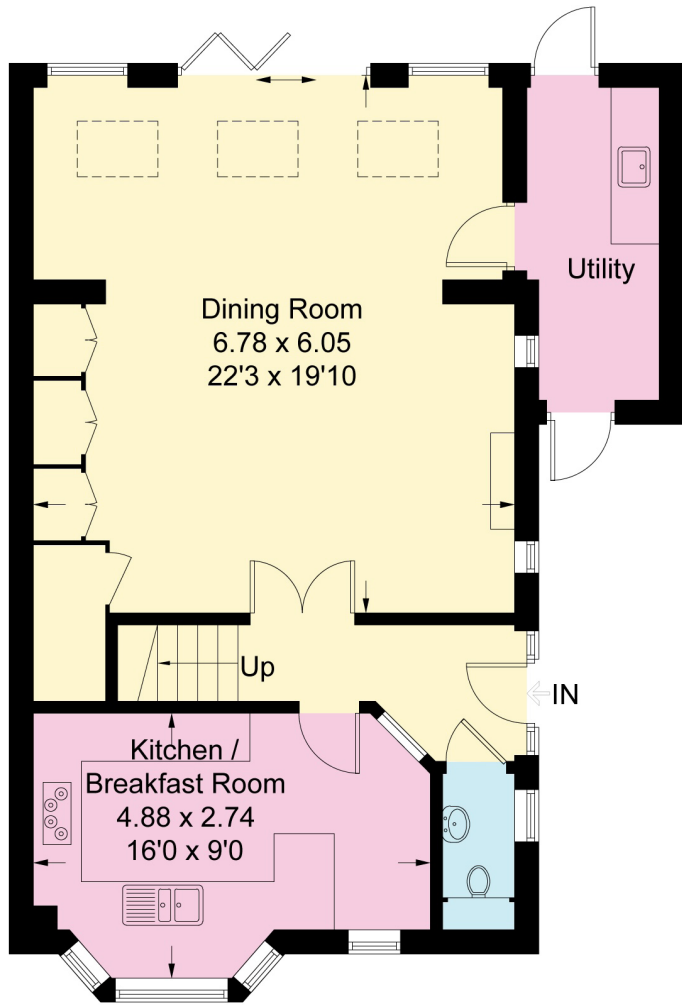

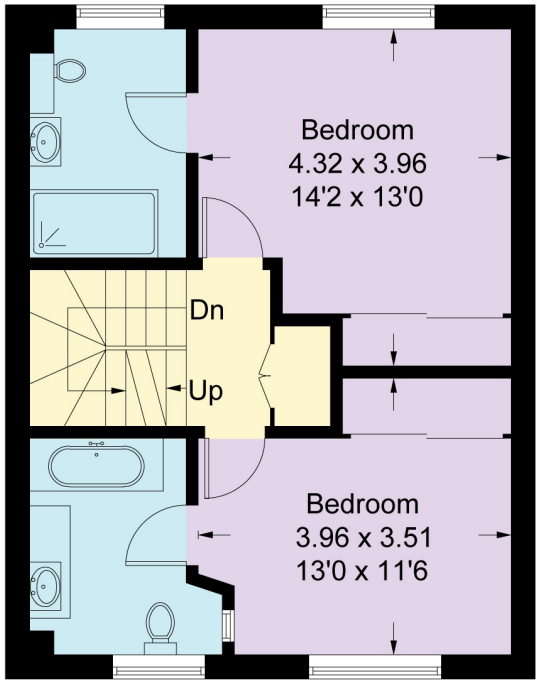

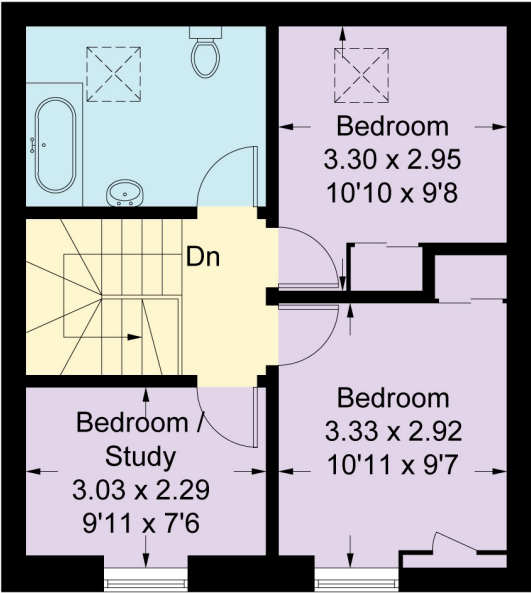


Ground Floor
