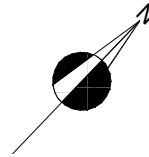
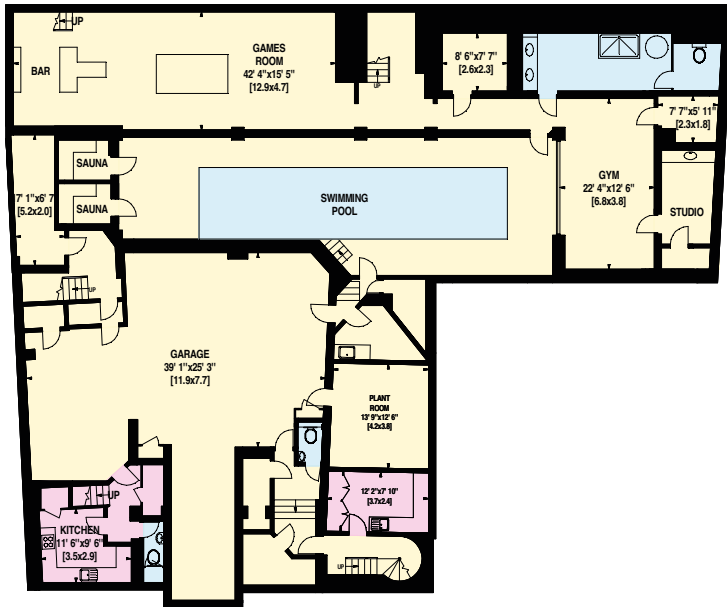

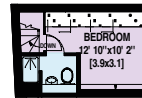
LOCATION

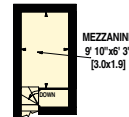

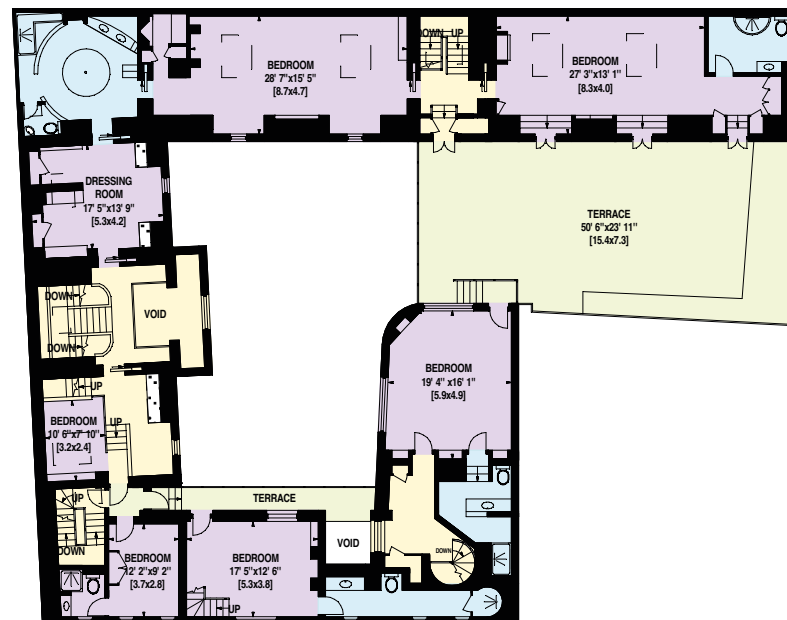
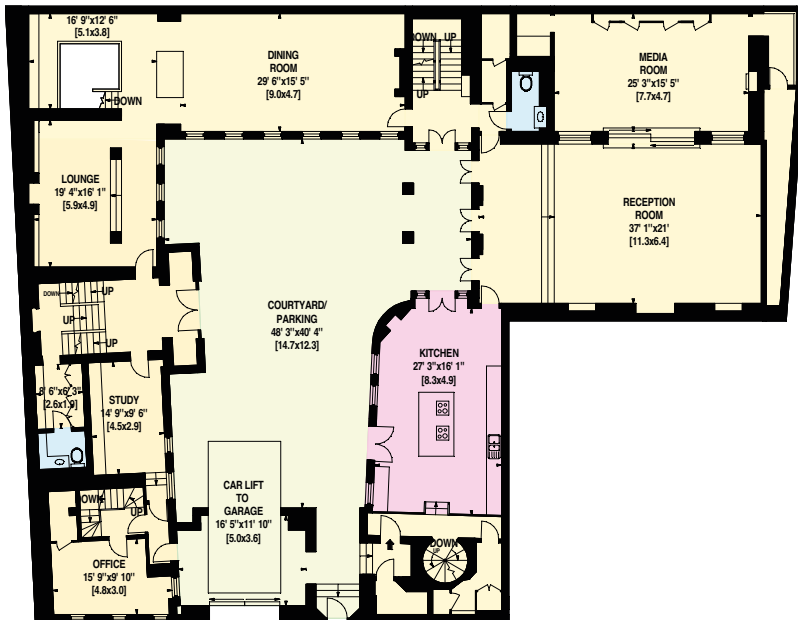
