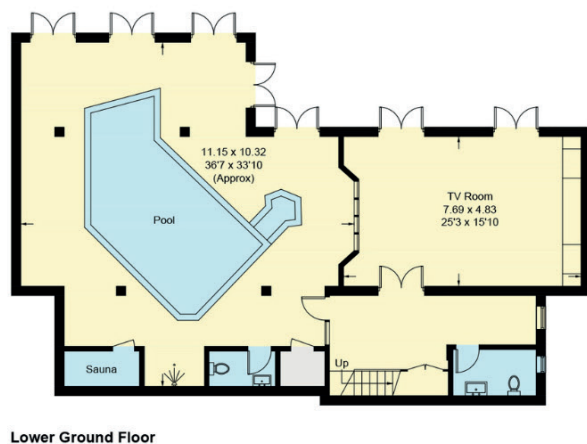
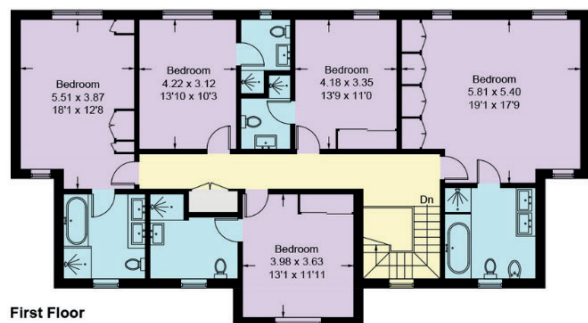
ABOUT THE PROPERTY
