ABOUT THE PROPERTY

Entry at ground floor level opens in to a welcoming reception hall which provides access to a light-filled and bay-fronted reception room. There are a number of period features on show including a beautiful fireplace with woodburning stove, cornicing and stripped floorboards. Glazed Crittall doors open in to the second reception room currently used as a play room/snug with further fireplace, cornicing and picture rails.

At the rear of the plan is the generous kitchen/dining/family room measuring 7.7m x 5m. An expansive space with a stylish shaker style kitchen, marble topped units, lime washed floors and plenty of light from the glazed doors leading out to the garden. The kitchen is well-equipped with ample storage, central island with breakfast bar and a range of in-built appliances. In addition there is a separate pantry. There is plenty of space for formal and informal seating, making this a great space for entertaining. Completing the ground floor is a useful WC and utility room.

Stairs rise to the first floor with the principal bedroom at the front elevation with ample in-built storage and four-piece bathroom suite. There is a guest bedroom at the rear served by a separate shower room. Two further bedrooms and a study can be found on the top floor, served by a modern bathroom suite and separate WC.
