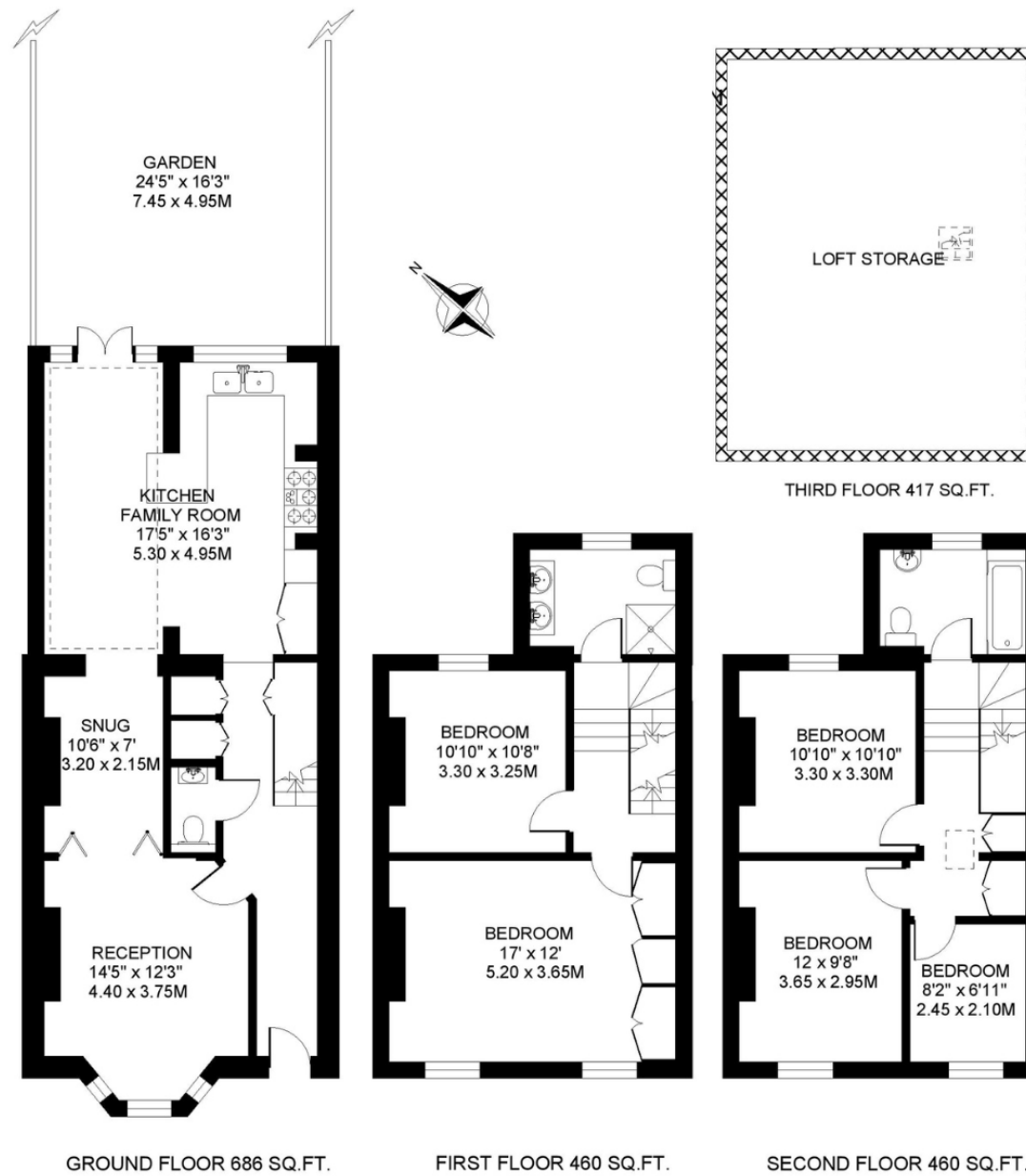
The first floor includes a full-width principal bedroom, a double bedroom and a shower room. The top floor provides three further bedrooms and a family bathroom, with ample loft storage above.
