## General information

## **2. How do we collect your information?**

### **Personal Identification Data**

Your data will only be collected if you inform us by telephone or email.

### **Technical Specifications**

Other data is automatically collected by our IT systems when you visit our website. This is mainly technical data of the calling device and stores this data and information in the log files of the server. We may record the types and versions of browsers used, the operating system used by the accessing system, the website from which an accessing system accesses our website (so-called referrer), the sub websites which are accessed via an accessing system on our website, the date and time of access to the website, an Internet protocol address (IP address), the Internet service provider of the accessing system and other similar data and information which serve to avert danger in the event of attacks on our information technology systems.

For security purposes, i.e. in order to be able to trace the attack in the event of attacks on our platforms, we store this data including the IP address for a period of 14 days and then delete the IP addresses and the data. The IP address is required during the connection in order to transfer the contents of our platform to your browser. The legal basis for the processing and subsequent storage of the IP address is a legitimate interest pursuant to Art. 6 para. 1 lit. f) GDPR. The legitimate interest with regard to the transmission of the IP address is that it is necessary to display the contents of the platform; the website cannot be displayed without the transmission of the IP address. The legitimate interest in limited storage is our security interest.

## **3. What do we use your data for?**

Part of the data is collected in order to ensure error-free provision of the website. Other data can be used to analyze your user behavior.

## **4. Categories of recipients of personal data**

We use external service providers for the purpose of hosting our website and for back-up services, so that personal data stored on our website is transmitted to them. We work with these service providers on the basis of the conclusion of order processing contracts in accordance with Art. 28 GDPR. The transmission is based on our legitimate interest in carrying out internal administrative activities efficiently and on the division of labour and in improving our products and services, on the basis of Art. 6 para. 1 sentence 1 lit. f) GDPR and. The hosting services we use serve to provide the following services: Infrastructure and platform services, computing capacity, storage and database services, security services and technical maintenance services that we use to operate this website.

## **5. Cookies and similar technologies**

We use cookies and active components (e.g. jQuery, a JavaScript application) to optimize the website accordingly. Cookies are small text files that are stored on your computer when you visit our website. If you wish, you can delete the cookies at any time. However, this can result in individual functions no longer being available to you. To delete cookies, please consult the help function of your browser.

We use only technically necessary cookies, i.e. cookies that are absolutely necessary for our websites and their functions to work properly, e.g. storing your cookie settings.

## 6. Links
